PARTICULARS SHEET

For all donations and pledges

This Particulars Sheet explains the details around each of the Payment Methods. Please ensure you read the details fully.

Payment Method:

(A) Cash Donation Now

- This is an unconditional donation for the Hundertwasser Art Centre project.
- Should the project not proceed, the Whangarei Art Museum Trust will apply those funds to the Whangarei Art Museum – for general purposes art acquisitions or gallery and other expenditure.
- A Charitable Donation Claim by the donor is available for the current year.

(B) Cash Donation Now, to be held in Trust until the Hundertwasser Project Starts

- The donation will be held in Trust until the project proceeds.
- The donor agrees that when the Hundertwasser Art Centre project proceeds, the donation will be transferred to the Hundertwasser Art Centre Project Account.
- Should the project not proceed the donation will be returned to the donor.
- The donor agrees that interest accruing on the funds will be retained by Whangarei Art Museum Trust to defray the establishment costs of the Hundertwasser Art Centre Project.
- The donor agrees that if they or the organisation cannot be found at the time of refund, the funds may be used by the Whangarei Art Museum Trust for general purposes.
- A Charitable Donation Claim can only be made when the funds transfer to the Hundertwasser Art Centre Project Account and become an unconditional donation. An applicable receipt will be issued at that time.

(C) A Pledge of \$1000 or over that the donor agrees to donate to the Hundertwasser Art Centre Project

- The pledge will be billed to the donor when the project proceeds, unless the donor nominates payment by instalments.
- A Charitable Donation Claim is available when payment is made and it becomes an unconditional donation.
- Should the donor require the pledge payment to be held in Trust, a claim is only available when the funds pass to the Hundertwasser Project account.

(D) A Donation of Services or Materials

Charitable Donations Claim

The Whangarei Art Museum Trust qualifies as a “donee organisation” under section LD3 of the Income Tax Act 2007. You may claim a donation tax credit (for individuals) or a deduction for donations (for organisations) for donations above \$5. You should retain this record for 7 years after the tax year in which the donation is made.

Personal Information

Please note your personal information is collected and kept for the purposes of recording and processing this pledge/donation. The Whangarei Art Museum Trust will not use this information for any other purpose unless you have agreed by ticking the application form.
